

## **INSTRUCTIONS FOR TRANSFER OF PUBLICLY TRADED SECURITIES**

The Ottawa Hospital Foundation (the 'Foundation') greatly appreciates your support. Under current tax regulations, your donation of publicly traded securities is exempt from capital gains tax only when you transfer the securities in-specie or in-kind to a charity.

## Electronic Transfer - Canadian or U.S. Securities

Please note the Foundation will issue a tax receipt for income tax purposes. The value of the receipt will be determined by the Fair Market Value of the securities on the date the securities are received in the Foundation's brokerage account, based on the market closing price for the day or, if sold prior to the close of markets, the sale value before commissions. In accordance with our Board Policy securities will be sold as soon as possible.
