Heroes ride for research


In September, our inaugural Ride the Rideau event brought together cyclists passionate about supporting cancer research. This one-day road-cycling adventure spanned 100 km and raised \$940,000 for cancer research.

As we like to say, our heroes fly on two wheels.

By way of scenic country roads and through revitalizing pit stops, Ride the Rideau cyclists followed the Rideau River from Lansdowne Park in Ottawa to tranquil Merrickville-Wolford. At the end of their journey, a barbecue and live entertainment awaited the cyclists and their supporters. Their victory in completing this event is leading to significant victories in cancer research.

Having a dedicated cancer research centre at The Ottawa Hospital Cancer Centre means the time it takes for discoveries to reach the bedside and benefit patients is reduced by half. Patients now have greater access to groundbreaking cancer therapies and clinical trials. Thanks to the support of our Ride the Rideau heroes, the new therapies being developed today in our community could save the life of a friend, a family member or a colleague tomorrow.

Thousands of Ottawa-area students from the Ottawa Catholic School Board hugged along the Rideau Canal (pictured at left) in May to secure a Guinness World Record while raising money for cancer research. The Foundation was one of four charities to receive a donation from Bear Hug III.

The students were successful on all fronts. They now hold the world record for the longest bear hug, which spanned about seven kilometres and lasted a full 10 seconds. They also gave \$72,091 to support cancer research at The Ottawa Hospital.

CyberKnife arrives, thanks to community support

In September, just a few months after its arrival, the CyberKnife (pictured above) was already improving treatment for cancer patients in our community, the same community that donated the \$3.5 million needed to purchase this state-of-theart and life-changing piece of equipment.

The Greely Lions Club charity gala and auction in April was one of many community events held to raise funds for the CyberKnife. Further support came from entrepreneur Brian Karam as well as Albert Monsour and Eli Njaim, who invited friends and colleagues from the Lebanese community to a fundraising dinner in November.

Contrary to its name, the CyberKnife does not use scalpels; it is the world's only robotic radiosurgery system. It offers hope to patients previously diagnosed with inoperable tumours and provides significantly reduced treatment times. Having the CyberKnife allows The Ottawa Hospital, which is one of only three hospitals in Canada to offer this technology, to treat more patients dealing with all types of cancers more efficiently.

"This specialized radiation treatment often allows patients to bypass the operating room," says Paula Doering (pictured above), Regional Vice-President, Cancer Services. "This is making a significant difference in the lives of our patients and families."



PRESIDENT'S BREAKFAST BREAKS RECORD

The 2010 President's Breakfast raised \$950,000, the most of any President's Breakfast to date. At the core of the success of the President's Breakfast are the volunteer table captains. These community and business leaders invite friends and colleagues from their own network to come to this one-hour event and be inspired

by personal stories, such as that of Stephanie Spooner and her father, Steve (pictured at left). More than 500 people attended the event. "It's a chance for people like myself to show that, yes, this Hospital is an important part of our future," says Co-Chair Jim Durrell, owner of Capital Dodge Chrysler Jeep Fiat Ltd.

Running for a reason



In May, hundreds of inspired individuals joined forces during Ottawa Race Weekend to contribute to the Run for a Reason Challenge. Whether they participated in the 2K or full marathon or collected pledges, they all shared in raising \$904,521 to make a tangible difference in patient care and research at The Ottawa Hospital.

Lacing up means more than just crossing the finish line; it means making a difference. Participants join the Run for a Reason Challenge because someone matters to them and that someone has needed, or will one day need, medical care. For that reason, each team in the Challenge raises funds for the area of the Hospital that means the most to them.

Teams are formed from within the Hospital walls, such as Strong Women (pictured below), who walked in support of women's health. Teams also hail from the four corners of our community. Students from Turnbull School (pictured below), for example, supported CFRA Radio morning host Steve Madely's Run for Research team, which raised funds for cancer research.

And all of their hard work is making a difference. Thanks to the fundraising efforts of the Partners Investing in Parkinson's Research team (pictured below), for example, the Ottawa Hospital Research Institute was able to recruit Dr. Tohru Kitada, who is furthering his groundbreaking research into Parkinson's disease.

CELEBRATING 50!

As a present to herself for her 50th birthday in October, Charlene Massia (pictured at left with her sister, Pauline (far left), and her brother, Bernard) launched her 50-50 Campaign to recruit 50 new monthly donors for The Ottawa Hospital Foundation. Impressively, this determined

volunteer recruited 53! Charlene was diagnosed with an aggressive form of breast cancer in 2006. "I'm living proof that research helps," says Charlene. "When I was diagnosed, my doctor told me I was lucky—the drug they put me on had not been available in Canada two years earlier. Without

research and clinical trials to approve that drug, I wouldn't be here." Charlene also sold tickets to her 50th birthday bash, which included dinner and dancing. The party raised \$10,000 for cancer research at The Ottawa Hospital and was attended by 218 supporters.

Research chair awarded

Canada's first Chair in Men's Health Research was awarded to Dr. Anthony Bella in August. Dr. Bella is a world-renowned urologic surgeon and men's health investigator at The Ottawa Hospital.

The \$2 million needed to secure this research chair was donated by the community. Two special members of our community were particularly supportive of this initiative. In recognition of Greta and John Hansen's significant contribution to this project, we were delighted to name the chair the Greta and John Hansen Chair in Men's Health Research.

Patients will benefit directly from Dr. Bella's research; he is investigating various approaches to reduce the side-effects of treatment for male cancers, such as prostate cancer.

"I get to tell patients every day that there is a good chance we can treat their cancer with a high probability of success. Unfortunately I also have to tell them that they may never get their full quality of life back," says Dr. Bella, Associate Scientist at the Ottawa Hospital Research Institute. "I think we can do better, and this research chair will greatly accelerate our progress."

In February, the Foundation gratefully accepted a gift from the Estate of Arthur M. and Ethel W. Cushing (pictured above). Under the careful stewardship of Jeffrey Beedell and Jennifer Ward, Estate Trustees, the Ethel

Ward Cushing Legacy Endowment Fund was established to further research, education and cancer care. Through the endowment, the generosity of the Cushings will live on, and their legacy will have a lasting effect on patient care and research in their community. Every year, several permanently endowed funds are created by donors in honour of a loved one or special occasion in their lives, and these funds reflect their special relationship with a particular area of the Hospital.

Virtual reality lab offers hope

An early holiday gift arrived at The Ottawa Hospital Rehabilitation Centre in December. The Rehabilitation Virtual Reality Laboratory opened featuring the CAREN system, which provides a safe and controlled environment for patients learning to cope with balance and coordination issues as a result of injury or disease.

The arrival of the CAREN system is the result of a partnership between The Ottawa Hospital and the Canadian Forces Health Services Group. The Foundation reached out to the community to raise the \$500,000 needed to house the technology—and the community responded!

In particular, employees of the Department of Foreign Affairs and International Trade (DFAIT) answered this call by holding two fundraising events—the DFAIT Moves 5K run/walk (pictured above) and an international online auction for DFAIT employees—which together raised \$100,000.

Further community support came from the annual Hope and Heroes event, which raised almost \$47,000 and was presented by the Ottawa Senators Alumni, Scotiabank Group and the Foundation.



GALA CELEBRATES RESEARCH

Researchers are shaping the future of health care, and marking their achievements is the raison d'être of The Ottawa Hospital Gala. Co-Chairs Gregory Kane, Q.C., Partner, Stikeman Elliott LLP, and Steve West, Chief Executive Officer, Nordion Inc., and Hicham Adra, Chair of the Foundation Board of Directors (pictured at left, from left),


Opinion



NOTES TO SUMMARY FINANCIAL STATEMENTS

Year ended March 31, 2011

The Ottawa Hospital Foundation / La Fondation de l'Hôpital d'Ottawa ("the Foundation") is a public foundation incorporated under the Canada Corporations Act. The mission of the Foundation is to inspire, enable and recognize community support for patient care and enable research at The Ottawa Hospital and the Ottawa Hospital Research Institute. The Foundation is a registered charity under the Income Tax Act (Business Number 869042747RR0001) and as such is exempt from income taxes and may issue charitable donation receipts.

1. Summary financial statements:

The summary financial statements are derived from the complete audited financial statements, prepared

in accordance with Canadian generally accepted accounting principles, as at and for the year ended March 31, 2011.

The preparation of these summary financial statements requires management to determine the information that needs to be reflected in the summary financial statements so that they are consistent, in all material respects, with or represent a fair summary of the audited financial statements.

These summarized financial statements have been prepared by management using the following criteria:
(a) whether information in the summary financial

statements is in agreement with the related information in the complete audited financial statements; and

(b) whether, in all material respects, the summary financial statements contain the information necessary to avoid distorting or obscuring matters disclosed in the related complete audited financial statements, including the notes thereto.

Management determined that the statement of changes in net assets and the statement of cash flows do not provide additional useful information and as such has not included them as part of the summary financial statements.
