# THE DA VINCI SURGICAL ROBOT

Thanks to the efforts of a group of community leaders, the da Vinci surgical robot is now a reality at The Ottawa Hospital. These dedicated volunteers reached out to their colleagues and the community to raise \$5 million to purchase this surgical system.

We were particularly delighted to announce two outstanding gifts toward this campaign in October. Stephen Greenberg and his wife, Jocelyne (pictured top left), donated \$1 million from The Stephen and Jocelyne Greenberg Family Foundation, and Linda Eagen, President and CEO of the Ottawa Regional Cancer Foundation (pictured top left with Tim Kluke, President and CEO of The Ottawa Hospital Foundation), also committed \$1 million.

Support for purchasing da Vinci was drawn from inside the Hospital and out. Dr. Rodney Breau, Surgical Oncologist in the Division of Urology (pictured above), spoke at numerous information sessions to highlight the benefits of da Vinci for patients, particularly prostate cancer patients. Robotic-assisted surgery contributes to better outcomes by facilitating less blood loss, less postoperative pain, smaller incisions, shorter hospital stays and faster recoveries—the results for which every patient hopes.

In the community, a number of fundraising initiatives contributed to the success of this campaign. The Ottawa Motorcycle Ride for Dad donated \$200,000 for da Vinci. Jennifer Smylie, Clinical Manager of the Ages Cancer Assessment Clinic (pictured top right, centre), accepted this generous donation from organizers (pictured top right, from left) Byron Smith, Jim Summers, Mike Pearson and Garry Janz.

## RIDE THE RIDEAU

The second annual Ride the Rideau, fuelled by Nordion, took place on a gloriously sunny September day and featured a scenic 100 km route from Ottawa to Merrickville-Wolford. The more than 715 participants raised \$1,829,544 for cancer research at The Ottawa Hospital. Funds supported a number of cancer research initiatives, including clinical trials and the development of novel targeted therapies. Ride the Rideau attracted riders and supporters from all walks of life, including Mike Tierney from the Hospital's Senior Management Team (pictured below). # LOOKING AHEAD

Constant innovation means always looking ahead to realize a vision. Our role at the Foundation is to honour the Hospital's vision by inspiring and enabling the community to help make it happen. The Foundation launched a number of campaigns this year. With your support, these will fund innovation well into the future.

#### **Establishing SABR Research Chair**

In July, the Foundation launched a \$1 million campaign to support a Spine and Brain Regeneration (SABR) Research Chair. The Chair will allow Dr. Eve Tsai, a neurosurgeon and associate scientist, to harness regenerative medicine to one day repair or replace damaged tissue in the spinal cord and brain. In November, Dr. Tsai appeared on the cover of *Women* of Influence magazine (pictured bottom left), in which she was recognized as one of Canada's top 25 Women of Influence in the health category.

**Expanding Breast Health Centre** To better serve patients, breast health services at the Hospital will be expanded and consolidated with one Breast Health Centre at the General Campus. This exciting expansion means—just to name a few of the improvements—the number of consultation and examination rooms will more than double and capacity for diagnostic imaging will increase. To help turn this vision into a reality, the Foundation launched a multi-year fundraising campaign in September.

#### **Funding Cancer Research**

In January, Steve West (pictured top left), CEO of Nordion Inc. and a Foundation Board member, rang the ceremonial victory bell in the Chemotherapy Unit of the Cancer Centre to mark the end of his treatments. Steve has been an enthusiastic supporter of Ride the Rideau, Eastern Ontario's largest single-day cancer fundraiser. In addition to confirming that Nordion will return as the Sept. 8, 2012, event's title sponsor, Steve announced the fundraising goal for his company is \$70,000, and Steve personally pledged to raise half of that extraordinary goal.

were conducted in accordance with Canadian Auditing Standard (CAS) 810, "Engagements to Report on Summary Financial Statements."


#### Other matter


